Dissertation Abstract: My dissertation centers on the epistemic justification of non-epistemic (e.g., social and moral) values in scientific classification. Philosophers typically think that non-epistemic values should not affect scientific classification. However, such values frequently affect classification in the human and biological sciences. The influence of non-epistemic values on scientific classification can be epistemically helpful, such as the use of feminist values in anthropology. But some uses of values can be epistemically harmful, such as androcentric values in biology. This dissertation tackles how and under what conditions incorporating values can produce epistemic benefits in scientific classification. I argue that determining when values provide epistemic benefits requires a careful scrutiny of a research program's social and historical context.
