COURSE INFORMATION

A critical and analytical examination of ethical and moral problems arising in and about information technology. Topics include: privacy; intellectual property; the ethics of algorithms; human-computer enhancement; online speech and expression; hacking; virtual reality; and issues relating to artificial intelligence, such as the moral status of artificial beings and the existential risk of superintelligence.

- Understand the nature, purpose, and methods of philosophical ethical inquiry and the basics of moral theory.
- Identify and appreciate the core issues, debates, and positions in information technology ethics and understand why they are important.
- Understand and critically respond to texts by identifying, extracting, and analyzing the philosophical arguments therein.
- Write clearly and cogently about the arguments concerning the ethical issues covered in the course, including: summarizing arguments, critically evaluating arguments, and making new arguments.

COURSE ASSESSMENT AND EVALUATION

Assessment Components

Weekly Critical Responses: Six (6), worth 5% each, 30% total (1-2 pages); Due on Mondays starting July 6th, except the week of August 3rd, when it is due on Tuesday August 4th, because of Family Day.

Mid-Term Assignment: 35%; **Due on or around July 31**st (exact date will be confirmed in mid-July). End-of-Term Assignment: 35%; **Due on August 18**th.

Assignments will be submitted on D2L. **Save a screenshot of your submission!** Glitches can, and have, happened, so it is in your interest to make sure you have a record of submission.

Writing and the grading thereof is a major factor in the evaluation of a student's work. However, you have some flexibility when it comes to the format of course assignments, so long as you can demonstrate the appropriate knowledge, understanding, and critical thought. I will explain more about this in a video uploaded to D2L.

There will be no mid-term exams nor a registrar-scheduled final exam.

Grading Scheme

Assignments will be graded on a scale from A+ to F per the following standard. I will post a grading rubric on D2L. To weight assignments and calculate the final grade, these letter grades will be converted into the standard 4.0 scale:

The arithmetic used to calculate your final grade will follow this formula: (Each Critical Response)(.05) + (Take-Home Mid-Term)(.35) + (Term Paper)(.35) = Final Grade

However, in cases of a significant, steadily rising trajectory, later work will be weighted more heavily than earlier work.

Note that, per University regulations, the highest possible Grade Point Value for your final course grade is 4.0, even if you are awarded an A+. However, should you get an A+ on an individual assignment, I will treat its value as 4.3.

Late Assignments

Every student is entitled to up to four (4) no-questions-asked grace days (including Saturdays and Sundays) during the semester, to be used at your discretion. You do not need to contact me to use these grace days.

However, if you use these up, then you must notify me if you will be handing in work late. If you talk to me about it, we will work something out. If you do not, then late assignments will be penalized one grade-step per day; i.e., a B+ assignment handed in one day late would receive a B, or if two days late, a B-, and so on.

Class Policies

I will be uploading video lectures on Tuesdays and Thursdays pertaining to the readings assigned for that week (see course syllabus on D2L). The amount of readings and lecture material corresponds roughly to what I would have covered had this been an in-person class meeting Tuesdays and Thursdays, though my video lectures will not be 3 hours long!

Indeed, because this class is being offered online and asynchronously, it will be different from how things would normally go. But I think this is the best way to give you flexibility to complete the class, since I know this is an unusual and possibly difficult time. However, I do want you to keep up with the readings and posted videos week-to-week, if possible, just so everyone is roughly at the same place at the same time. The course will work best if we're all moving through it together, especially since everyone has the same due dates for assignments.

Our TA, Husna Farooqui, will be running weekly drop-in question and answer sessions on Zoom, so that will also be a good way to make sure you're up to speed. Details will be posted on D2L.

Just as I am allowing flexibility for you, please do so for Husna and me as well—we are only human, too. Do feel free to contact us by email at any time, but please allow for 24-36 hours for us to respond, and know that we will not check email on evenings and weekends. We may respond more quickly sometimes, but do not assume that we always will.
