COURSE INFORMATION

Play is a broad range of activities that includes games, sports, pretending, joking, and storytelling. This class is a philosophical exploration of the notion of play. Some questions we may consider are: What is the purpose of play? Can something be just a joke? What makes one game different from another? In what way do the rules of a game constrain us? What are we doing when we pretend? What makes something true in make-believe?
