#### **COURSE INFORMATION**

A close reading of an early work of Nietzsche's, On the Use and Disadvantage of History for Life, and one of his last works, Twilight of the Idols.

## PREREQUISITE(S)

3 units from <u>Philosophy 309</u>, 311, 333, 359, <u>Religious Studies 363</u>; and 3 units in a course labelled Philosophy.

### **COURSE OBJECTIVES/LEARNING OUTCOMES**

- An understanding of the core elements and development of Nietzsche's philosophy.
- Ability to critically digest, interpret, and analyze two important works of Nietzsche's.
- Ability to write a convincing argument that takes adequate account of alternative positions.
- An enhanced ability to think through philosophical issues.
- The experience of reading a book carefully.

- Course work is generally to be submitted in the class, but may also be submitted on the D2L site's Dropbox, and may be e-mailed to the instructor directly.
- A passing grade on each component of the course is required to pass the course as a whole.
- Each student is entitled to up to two days of grace beyond the specified deadline for assignments, to be used at their discretion throughout the semester. Students do not need to request permission for those days. Late work beyond the two days will be penalized at the rate of 1% of the course grade for each day late.
