Course Description

This course will look at the politics of our production, regulation and consumption of food. The course will pair core readings in political philosophy (property, distribution, critique of capitalism, liberty and paternalism, gender, class and race inequality) with issues about the production, regulation and consumption of food. Topics to be covered include food insecurity, food sovereignty and food waste (property rights and distribution); food production (gender, race, class, property rights, distribution); and food regulation (liberty and paternalism). Our discussions on these issues will also look at food discourse including obesity discourse and alternative food discourse (class, gender and race).

Course Learning Outcomes

- Understanding of some foundational issues in political philosophy and how these relate to our production, regulation and consumption of food
- Ability to write a convincing argument that takes adequate account of alternative positions;
- Ability to engage in constructive, respectful, oral and written argumentation.

Prerequisites:

Two previous courses in Philosophy, one of which must be 249, 397, 425, 449 or 453 and at least one of which must be a 400 level or higher; or consent of the Department.

Course Assessment

- Weekly Questions 20%
 - Each week you are required to submit a question on the reading—the question should indicate to me that you have done the reading carefully enough to be philosophically puzzled or confused by it. These are to be handed in on index cards at the beginning of the class and will help to structure the class discussion. You may skip two weeks for a total of 10. These are graded Pass/Fail

- Participation 10%
 - You are expected to expand on your weekly questions as well as take part regularly in class discussions. Good participation requires not only contributing but also interacting respectfully with others which requires attentive listening and responsiveness to others as well as giving others space to contribute.

- Activity Assignments 30%
 - You must choose 3 activity assignments. These might include keeping a food journal or blog, taking the Oxfam challenge, attending the food sustainability lecture on January 26 and writing a report, food waste investigation, volunteer activity, dietary change. Due dates will depend on activities chosen. Each student should meet with me in the first two weeks to discuss which activities they are interested in pursuing. These will be graded Pass/Fail. Late assignments will be accepted with appropriate reasons presented.
 - Students may, if they wish substitute one short academic paper (1500-1800 words) for one of the activity assignments. This paper will be assigned a numerical grade.

- Final paper 40%
 - The final paper is due Monday April 17. You may submit electronically or you may bring me the paper in my office during my office hours (3-4:30).
 - By March 15 you must submit a 1 page paper proposal plus (preliminary) bibliography. These are to be handed in at the beginning of class.
 - By March 24 you must submit a draft of the paper. These will be distributed and will be workshopped in the class. These are to be submitted on D2L prior to midnight.
 - Late papers will be docked four points per day.
