Course Description

Biomedical Ethics engages in debates on ethical issues that relate to practices, or proposed practices, in health care and medical research. In this course we will participate in these debates by critically assessing and developing arguments that concern these issues. Some of the topics covered in this course are euthanasia, abortion, genetic engineering, and resource allocation. The final grade will be determined by two in class tests and one take home test. The tests involve writing essays on assigned topics. Policy on missed in class tests and late take home tests: zero will be the assigned grade unless the absence is university approved. **The take home test will not be accepted via email under any circumstances.** There is no Registrar-scheduled final exam for this course.
