Course Description

We will discuss recent work in traditional "single agent" epistemology as well as the growing field of social epistemology. For the first half of the course, we'll consider skeptical worries about knowledge as well as various responses to skepticism that emphasize the role that practical factors play in claims about whether a subject has knowledge. For the second half of the course, we'll move beyond the "single agent" model and focus on issues concerning testimony, expertise, and the epistemological significance of peer disagreement.

Evaluation

- **Participation (20%):** Active engagement in class discussion, participation in various group activities, and performance on pop quizzes. Though attendance is not required, it is impossible to receive participation marks without attending class.
- **5 Reading Analyses (40%):** Short (maximum 1 page) paper that presents the main argument of that day's reading in standard form. You may earn up to 1% of extra credit toward your final grade if you construct a single plausible objection (per reading analysis). Your lowest reading analysis mark is dropped. *Due By: Oct 2, Oct 16, Oct 30, Nov 13, Nov 27.*
- **Final Paper (40%):** 1,000-2,000 word (250 words/page) expository essay. *Due By: Dec 4.*
- There is NO Registrar-scheduled final examination for this course.

Grading Method

Writing and the grading thereof is a factor in the evaluation of your work for this course. Grades are not curved or rounded. Final grades are computed according to the following schema:

Policy on Handing In Assignments

Policy on Late Assignments

Assignments are officially due the moment class is scheduled to begin. All other assignments are late. Late assignments are penalized 50% of the mark. Late assignments must be handed-in by the first subsequent class. (In other words, the deadlines for late reading assignments are as follows: Oct 7, Oct 21, Nov 4, Nov 18, and Dec 2, respectively. The deadline for late final papers is Dec 9.) All late assignments not turned-in by the late deadline are not accepted—and are therefore missing.

Policy on Missing Assignments

Missing any assignment results in an automatic F for the course final grade.

Policy on Extra Credit

You may earn a bonus 1% toward your final grade for each assignment you submit earlier than its due date. Additional special extra credit opportunities may be randomly offered in-class throughout the semester.

Policy on Contested Marking

If you are dissatisfied with a mark that you have received on an assignment, you have at most two weeks from the day the assignment is handed back in-class to contest it. To contest a mark, you must submit a concise, sound argument in writing explaining what your mark should be and why. After the two week window has passed, your mark cannot be contested for that assignment. Failure to comply with the prescribed protocol results in the forfeiture of the right to contest your mark.
