### COURSE DELIVERY INFORMATION

This class is concurrently scheduled with Philosophy 499, which meets on Zoom each Tuesday from 11am-12:15pm. Students will also have access to all the asynchronous learning activities for this class—see the course activities section below and the D2L site for more information.

In addition, students in 601 will meet separately with the instructor via Zoom for 75 minutes a week (time TBA).

### COURSE DESCRIPTION

Our concern in this course will be with the metaphysics of race and gender. Do races and genders exist? If so, what kind of thing are they? We will consider a variety of answers to these questions, including various versions of essentialist, social constructionist, and error theories. We will also look at the historical development of these views as well as their ongoing political impact.

### COURSE OBJECTIVES/LEARNING OUTCOMES

- Deep knowledge of essentialist, social constructivist, and error theories with respect to race and gender.
- Robust understanding of the standard arguments for and against these positions.
- An understanding of the historical origins of our ideas of race and gender.
- An understanding of the ways in which these ideas impact on policy and political viewpoints.
- Ability to explain these issues to a non-specialist audience.
- Ability to write a convincing argument that takes adequate account of alternative positions
- Ability to engage in constructive, respectful, oral and written discussion.

**PREREQUISITE(S):** Two previous courses in Philosophy, at least one of which is at the 300 level.

## COURSE ASSESSMENT AND EVALUATION

Assessment in this class will be based on the following components:

**Weekly questions:** Each week, the day before the 601 only meeting, I'd like you to submit a question based on one of the readings for that meeting. The question you write should demonstrate that you've read the reading well enough to be at least confused by it. As my colleague David Dick points out, "confusion is a philosophical heuristic, it either helps you identify a place where you don't understand, or where the argument doesn't make sense. Either one of these counts as philosophical progress."

Weekly questions and their explanations/context should not generally be longer than 300 words. An example will be posted on D2L.

Over the 13 weeks of the term you need to submit 10 weekly questions. It's up to you which week, beyond the first, you wish to submit questions on. No extra credit will be given for questions beyond the ten.

Questions should be submitted to the Dropbox set up on D2L for this purpose.

**Participation in discussion:** You are expected to be an active contributor to the discussion in the graduate student only meeting each week. It is also expected that your contributions be respectful and constructive.

**Briefing papers:** Two briefing papers, one on gender and one on race, are required for this class. These papers should be approximately 1500 words, and should explain the standard range of answers to the questions "What is gender?" and "What is race?" in language accessible to a non-specialist.

Briefing papers will be graded pass/fail. Failing papers may be resubmitted until such time as they are judged a pass.

The initial submissions for both papers should be made by **noon on February 13<sup>th</sup>**. They may be made before that. More detailed instructions will be provided in the first week of classes.

The letter grade for the briefing papers portion of the final grade calculation will be determined as follows:

2 Passing Briefing Papers = A (4.0)

1 Passing Briefing Paper = B (3.0)

0 Passing Briefing Papers = F (0.0)

**Term Paper:** The term paper for this class is due on **April 25<sup>th</sup> at noon**. More detailed instructions on this paper will be provided after the winter break.

Students wishing instructor feedback on a draft paper should submit the draft by April 10<sup>th</sup>, and must book a meeting to discuss the draft with the instructor (written feedback will not be provided).
